

We would like to take this opportunity to thank you for doing business with **AMERICAONE**. It is our intention to make sure you, our customer, have fully understood all of the details pertaining to the Service which we have the privilege of providing for you. Listed below are the points which were discussed with you by our sales representative. Please review them carefully and sign below. After you have reviewed this statement, if you have any questions, please discuss them with your representative at this time.

PROCESSING AGREEMENT

- (a) I understand that my Merchant Rebate is \$ _____ per cash withdrawal transaction for a surcharge of \$ _____, with the ATM configured to dispense \$ _____ denominations.
- (b) I understand that I am responsible for my fees incurred for dedicated phone and electrical work (if required) and that this work must be completed prior to installation. I further understand that without both electrical and phone line in place, the ATM cannot be installed.
- (c) I understand that once the per-notification has been established with my bank, funds are deposited within 24-72 banking hours, excluding Saturdays, Sundays, and bank holidays.

CASH PURCHASE AGREEMENT (If Applicable)

- (a) I understand that I have agreed to a purchase of the **AMERICAONE** Cash Dispenser (ATM) for \$ _____ which includes installation, training, freight and signage. Applicable Sales Tax is additional.
- (b) I understand that there is a 50% deposit required to ship machine, \$500 of which is non-refundable if ATM request is voided.

LEASE AGREEMENT (If Applicable)

- (a) I understand that all financing arrangements are with a third party and are proposed according to my credit worthiness. I understand that I am obligated to the finance source independent of my obligations with AmericaOne.
- (b) I understand that when all terms and conditions of this lease have been satisfied, I have the option to buy the equipment at the end of the lease period for 10% of the purchase price.
- (c) I understand that once the lease has been executed, it is non-cancelable. However, the lease can be paid in full prior to maturity or it may be transferred to a credit worthy merchant, providing the leasing company approves the transfer.
- (d) I understand that the signer of the lease contract will be personally guaranteeing the lease.
- (e) DEPOSITS:
I understand a minimum deposit of \$500 will be collected at the signing of this disclosure and shall be used towards monies required to execute the lease (i.e. first payment, last payment, security deposit, documentation fee's). Any unused portion will be refunded to the Merchant by **AMERICAONE**. The next lease payment will be due approximately thirty (30) days after installation. Because of the significant investment of time and incurred internal processing costs, Merchant will be liable for a \$500 cancellation fee if the ATM request is voided.
- (f) I understand that a \$199 non-refundable Application Fee will be assessed if the lease is not approved.
- (g) I understand that a photocopy of my drivers license is required.
